

## **Return and Refund Policy**

If, for any reason, you are not completely satisfied with a purchase We invite you to review our policy on refunds and returns. The following terms are applicable for any products or services that you purchased with us.

### **Interpretation and Definitions**

#### **Interpretation**

The words of which the initial letter is capitalized have meanings defined under the following conditions.

The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

#### **Definitions**

For the purposes of this Return and Refund Policy:

**You** means the individual accessing or using the Service, or the company, or other legal entity on

behalf of which such individual is accessing or using the Service, as applicable.

**Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Bark & Birch Ltd, Charan House, 18 Union Road. **Service** refers to the Website. **Website** refers to Bark & Birch, accessible from [barkandbirch.com/](http://barkandbirch.com/)

**Goods** refer to the items offered for sale on the Service. **Orders** mean a request by You to purchase Goods from Us.

## **Your Order Cancellation Rights**

The deadline for cancelling a Goods Order is 14 days from the date on which you received the Goods or on which a third party you have appointed, who is not the carrier, takes possession of the product delivered.

In order to exercise your right of cancellation, you must inform us of your decision by means of a clear statement. You can inform us of your decision by:

We will reimburse you no later than 14 days from the day on which we have made a decision regarding your order cancellation notice.

## **Conditions for Returns of Goods**

In order for the Goods to be eligible for a return, please make sure that:  
The Goods were purchased in the last 14 days  
The Goods are in the original packaging

The following Goods cannot be returned:

- The supply of Goods made to Your specifications or clearly personalized.
- The supply of Goods which according to their nature are not suitable to be returned, deteriorate rapidly or where the date of expiry is over.
- The supply of Goods which are not suitable for return due to health protection or hygiene reasons and were unsealed after delivery.
- The supply of Goods which are, after delivery, according to their nature, inseparably mixed with other items.

We reserve the right to refuse returns of any merchandise that does not meet the above return conditions in our sole discretion.

## **Conditions for cancellation of services**

Under no circumstance do we provide a part or full refund for any of our partly used dog services including but not limited to:

- Doggy daycare credit packages
- Dog board & train services,
- Dog 121 training packages
- Grooming services
- Hotel boarding.

## **Returning Goods**

You are responsible for the cost and risk of returning the Goods to Us. You should send the goods to the following address:
